



Shawano Cares About Critters Foster Care Agreement

Please read all requirements below:

- The animal(s) under your care are the property of SCAC.
- SCAC will provide veterinary care for the animal(s).
- Caregiver agrees to maintain ongoing contact with SCAC as to the health and status of any foster pet(s).
- If the animal(s) is in need of veterinary attention, shows any signs of illness, is lost or injured, the caregiver agrees to contact SCAC (**phone?**) immediately before transporting to the veterinarian, except in emergencies.
- Any transported animal(s) will be at caregiver's expense. SCAC is a volunteer organization and cannot reimburse travel expenses.
- If the caregiver is unable or no longer wants to care for the animal(s), they agree to contact SCAC immediately. SCAC agrees to remove the animal(s) from the caregiver's premises as soon as possible.
- The caregiver agrees to provide food, fresh water and a clean litter box (cats only) on a daily basis.
- Food and litter will be provided by SCAC. Any food/litter purchased by the caregiver will be considered a donation. Thank you!
- The caregiver agrees to keep the cat/kitten(s) indoors at all times. Dog/puppy(s) must be on a harness/leash whenever outside. All cat/kitten(s) must be transported in a carrier. In the event an animal gets loose, the caregiver agrees to contact SCAC at once.
- The caregiver agrees that a representative from SCAC may call or visit to check on the health status of the foster animal(s) and agrees to allow access to Board-approved volunteers in the home for this purpose.
- SCAC volunteers may request to visit the foster animal(s) to take photos and videos of them for marketing purposes.
- The caregiver understands that SCAC volunteers may remove the foster animal(s) for veterinary or other purposes. If the caregiver's home is determined not to be the best environment for a particular foster animal's needs, it may be requested that the caregiver transfer the foster to another foster home.
- The caregiver agrees not to allow foster animal(s) to be removed from the premises, and not to give or adopt the animal(s) or any of their offspring to any third party without prior approval of SCAC.
- The caregiver agrees to complete an adoption application and pay all applicable adoption fees if interested in adopting animal(s) being cared for.

- The caregiver agrees that the adoption of the animal(s) into a permanent home will be handled by SCAC. SCAC will be responsible for all marketing of adoptable animals, including social media. Anyone interested in adopting the animal(s) shall be referred to SCAC.
- The caregiver agrees that SCAC is not responsible for any physical injuries, bites, allergies, scratches and damages to the foster home including furniture, woodwork, curtains, etc.
- The caregiver recognizes that the health of the foster pet(s) is not guaranteed and there is a risk to my existing pets' health with any new foster brought into the foster home environment. Caregiver will not hold SCAC liable for any health conditions that may arise to personal pets due to a foster care pet being exposed to personal pets. Caregiver will follow the quarantine guidelines outlined by SCAC to minimize the health risks to personal pets.
- Everyone in the household knows about and agrees to having the animal(s) in the home.
- Caregiver agrees to notify SCAC if caregiver contact information changes and/or caregiver moves.

I understand the terms of the preceding agreement and agree that it is in the best interest of the foster pet(s). I will abide by all the conditions stipulated.
